The Hyderabad Resolution in November 2016 and its implementation in December 2016 runs counter the advice. it seems to us that GAC advice was not clearly taken into account in that case. We think that ICANN Switched to PATH 1 (slide 4) to PATH 2 even if it was clear to ICANN that governments want to have a say in this. But we agree with our colleagues from Brazil and Argentina that now it's important to find a way forward.

Manal Ismail - Egypt: (19:52) Just to re-iterate my comments in writing: On the process aspect il bellieve there was a disconnect, which I believe took place right after the public comment .. On the substance side, measure 1. is voluntary hence cannot be counted on; measure 2. is an excellent one yet a bit vague in terms of implementation; and measure 3. moves the burden from the registry to the govenments, without guarantees .. But it's important that we work constructively and find a way forward ..
